



Poso Creek IRWM Plan Implementation Activity and Correspondence for November and December 2017, and January and February 2018

Summary:

- North Kern WSD submitted second Quarterly Report and Reimbursement Request to DWR for the Poso Creek IRWM Plan Update. The report detailed work completed from October 1, 2017 through December 31, 2017. Again, the main effort during the quarter was associated with efforts to complete the water quality section.

- The draft water quality chapter to fulfill the 2016 IRWM Plan standards and requirements was under internal review. Additional sampling coordination with Self Help may occur through coordination efforts with SHE and CWC as part of DAC outreach.
- The Final USBR Report for Shafter-Wasco Kimberlina Spreading Grounds was completed. In addition, Reclamation completed an audit of the Project.
- Districts have completed signed agreements with DWR and Reclamation for funding awarded in 2016 and 2017; all but the Drought Contingency Planning funds are now in agreements.
