## **SGMA Updates and Discussion**

General Manager, Jason Gianquinto, provided the Board with an update on the District's SGMA related activities, highlighting the draft Staff Report received from the State Water Resources Control Board (SWRCB). Mr. Gianquinto noted that based on the preliminary review of the 2024 Draft GSPs, State Board Staff felt that the 2024 GSPs were deficient and recommended a probationary hearing which is scheduled for February 20, 2025. Mr. Gianquinto noted that there will

be two SWRCB staff workshops prior to the hearing, and discussed responses, public notices, and tours of the subbasin for State Board Members in efforts to achieve an adequate GSP. Mr. Gianquinto also noted the District is seeking District landowners to make public comment at the upcoming probationary hearing.
