SEMITROPIC WSD GSA UPDATE

At 12:52 p.m., the Board President, Dan Waterhouse, declared a meeting of the Semitropic Water Storage District Groundwater Sustainability Agency.

SGMA Updates and Discussion

The General Manager, Jason Gianquinto and GEI Consultant, Larry Rodriguez provided an update on the District's SGMA related activities. Mr. Gianquinto noted that at a recent board meeting State Water Resources Control Board (SWRCB) staff presented the SWRCB with their proposed schedule for when probationary hearings for the 6 groundwater subbasins deemed inadequate will be noticed for hearing. The hearing for the Kern County subbasin was proposed to be scheduled after the hearings for the Tulare, Tule, and Kaweah subbasins, and was estimated to be scheduled for probationary hearing as early as April 2024. To date, no formal hearing notice has been issued for any of the subbasins. Mr. Gianquinto further noted that if the District were to have a revised GSP in place it would need to be completed by December 2023 to allow for adequate review time.

The GSA meeting concluded at 1:18pm.

SWRU - Construction Update by W.M. Lyles

W.M. Lyle's Representative, Rick Amigh provided an overview of their progress report which was provided with the Board Package.

Consulting Engineer's Report

Larry Rodriguez from GEI Consultants presented and summarized GEI's "Consulting Engineers Report on Projects for June 2023" for work during June 2023, which was accepted for filing.

Balance Public Relations.

President Waterhouse noted that Dean Florez of Balance Public Relations was not present today, but that Mr. Florez's Monthly Report for June -July was included with the Board Packet.

Greg Allen of REDTrac provided a brief update on the Energy Cost Allocation Reports.

INFORMATIONAL AND UP-DATE ITEMS

Manager Gianquinto noted that the Staff Report, titled "District Activity During June 2023," dated July 6, 2023, was included with the Board Packet. In addition, the following items were discussed:

The State Water Contractors are continuing to engage with DWR to respond to public comments on the draft EIR for the proposed Delta Conveyance Project (DCP), refine operations criteria and modeling, and to prepare the DCP amendment to the SWP long-term water supply contracts should the Project be approved. DWR is expecting that the Final EIR will be completed by the end of 2023. The Final EIR will include responses to comments and edits to the Draft EIR, as necessary to respond to comments.

As previously noted, on April 20, 2023, the SWP Allocation was increased from 75 to 100%.

The District, for the month of June increased delivery of Article 21 water to

replace the reduced Kern River flows via Buena Vista WSD. The District's ability to take Article 21 at the Kern Water Bank and in District is limited due to preference for maximizing delivery of Kern River Lower River Water via the KCWA which started on March 17th. The District for the month of June was blocked from recharging water at the Pioneer Project as the recharge participants are banking for overdraft correction. On July 1st, the District resumed recharge operations at the Pioneer Project.

Ms. Isela Medina, District Engineer, provided an update on the High Speed Rail Project.

Mr. John Lynch, District Superintendent, provided an update regarding O&M activities, noting that the Wegis Pumping Plant had a 1500KVA 12470-416OV station class transformer failure. After a nationwide search the District was successful in locating a 2500KVA transformer.

At 1:44 p.m. President Waterhouse adjourned the Regular Board meeting.
